### ANDERS ÅSLUND

*Economist and Senior Fellow at the Atlantic Council*

Dr. Anders Åslund is a senior fellow at the Atlantic Council and an Adjunct Professor at Georgetown University. He is a leading specialist on economic policy in Russia, Ukraine and Eastern Europe. Dr. Åslund has served as an economic adviser to several governments, notably the governments of Russia and Ukraine. He has published widely and is the author of 15 books and has edited 16 books. His most recent book is *Russia's Crony Capitalism: The Path from Market Economy to Kleptocracy* (Yale UP 2019). He was a professor at the Stockholm School of Economics and the founding director of the Stockholm Institute of Transition Economics. He has worked at the Peterson Institute for International Economics, the Carnegie Endowment for International Peace, the Brookings Institution, and the Kennan Institute for Advanced Russian Studies at the Woodrow Wilson Center. He served as a Swedish diplomat in Kuwait, Poland, Geneva, and Moscow. He earned his PhD from Oxford University. He is a member of the Russian Academy of Natural Sciences.



### ADAM BARTHA

*Director of EPICENTER*

Adam Bartha is the Director of EPICENTER, a network of nine leading free-market think tanks from across Europe. He is responsible for the coordination and cooperation of the network and for organising the private and public events programme in Brussels. Adam gives regular talks on topics ranging from the rule of law, authoritarian populism, free market reforms, and the political affairs of the CEE region.

Adam was previously European Outreach Manager at EPICENTER and a Koch Summer Fellow in the Publications Department of the Independent Institute in California. He also has experience in domestic party politics in Germany and Hungary. Adam has a BA (Hons) in Politics and International Relations from the University of Sheffield and an MSc in Political Theory from the London School of Economics. Adam is fluent in English, German and Hungarian.

Svetla Kostadinova is the executive director of the Institute for Market Economics (IME) in Bulgaria (<http://ime.bg/>) which is the first and oldest independent economic policy think tank in Bulgaria. Her areas of expertise include labor market, budget policy and government efficiency.

Under Ms. Kostadinova's management, the IME advocated successfully for several impactful reforms (flat tax, business registration, legislative process) and positioned the organization as the most influential economic think tank in the country. IME produces in-depth research, conducts fact-based advocacy, has a very active media presence, organises events and does regular monitoring of public policy. Ms. Kostadinova is a member of the Bulgarian Macroeconomic Association and was ranked as the 29th most influential woman in Bulgaria by Capital Weekly magazine (2012) and was recognized as the 19th most influential woman in Bulgaria by Forbes Bulgaria magazine (2015). Ms. Kostadinova holds a Master's degree in Finance from the University of the National and World Economy in Sofia, Bulgaria.



## MARTIN KOTHÉ

*Friedrich Naumann Foundation*

Martin Kothé is FNF's Regional Director ESEE and based in Sofia, BG. A journalist by profession, he started his career in the late 80's at the BBC's German Service in London. He later moved on to Deutsche Welle Radio, VOX TV, RTL West Live and n-tv where he served as a parliamentary correspondent. In 1999, he became the spokesperson of the German liberal party, FDP. From 2004 - 2010, he served in the same function to German President Horst Köhler. ## ELENA LEONTJEVA

Elena Leontjeva is co-founder and President of the Lithuanian Free Market Institute (LFMI). Elena led LFMI from its inception until 2001 and returned to serve as the organisation's president in early 2020. Elena Leontjeva played a key role in building the legal and institutional foundations for Lithuania's economy, including the Currency Board and the Litas Credibility Law, the securities market, banking, tax and budget reforms, private pension insurance, downsizing state functions and deregulation known as the Sunset and Sunrise initiatives. She served as senior economic advisor to President Valdas Adamkus and state counsellor on economic reform issues under six administrations. Elena has originated and led an interdisciplinary project Scarcity, Morality and Public Policy and co-created a documentary Sublime Thirst. In 2020, Elena finished writing a novel.



## MARIN LESSENSKI

*Open Society Institute*

Marin Lessenski is Program Director of the European Policies Program of the Open Society Institute in Sofia. He holds an MA in Southeast European Studies from the Central European University, Budapest and an MA in History from the University of Sofia. He has been a Freedom House Visiting Fellow with the Hudson Institute's Center for European and Eurasian Studies and the Center of National Security Studies. He has also been a participant in the Transatlantic Young Leaders Program of the Aspen Institute in Berlin. At OSI-Sofia, he is responsible for the Media Literacy Index, focusing on societies' resilience potential to fake news and the "post-truth" as well as the Catch-Up Index, which measures the convergence or divergence of European countries along key economy, democracy, governance and quality of life indicators, with a focus on CEE.

Brad Lips is the Chief Executive Officer of Atlas Network, which increases opportunity and prosperity by strengthening a global network of independent civil society organizations that promote individual freedom and remove barriers to human flourishing. Since he became CEO in 2009, the budget of Atlas Network has more than doubled and the scope of its programs has extended worldwide. He is the author of a monograph titled *The Freedom Movement: Its Past, Present, and Future*. Lips is a member of the John Templeton Foundation, Templeton World Charity Foundation, and Templeton Religion Trust. He serves on the boards of directors of the American Friends of the Institute of Economic Affairs and the Institute of Economic Studies—Europe. As a member of the Mont Pelerin Society, Lips chaired the Organizing Committee of its General Meeting in 2016. Prior to joining Atlas Network in 1998, Lips co-founded an Internet start-up, conducted equity research for Smith Barney, Inc., and worked in a policy research capacity for the Progress & Freedom Foundation. He has spoken on five continents on solutions to poverty, and his work has been published in *The Wall Street Journal*, *Regulation*, *National Review Online*, *Investor's Business Daily*, *The Daily Caller*, *Forbes*, *Fox News*, *American Spectator*, *American Thinker*, and *RealClearPolitics*. Lips received his MBA from the Goizueta Business School of Emory University and his undergraduate degree from Princeton University. Brad lives with his wife, Stephanie, and their four children in Falls Church, Virginia.



## SAULIUM MATULEVICIUS

He is the author of *Realizing Freedom: Libertarian Theory, History, and Practice* (expanded edition 2014), and the editor of *The Morality of Capitalism* (2011), *After the Welfare State* (2012), *Why Liberty* (2013), *Peace, Love & Liberty* (2014), and *Self-Control or State Control? You Decide* (2016). Palmer received his B.A. in liberal arts from St. Johns College in Annapolis, Maryland, his M.A. in philosophy from The Catholic University of America, Washington, D.C., and his doctorate in politics from Oxford University.
